- (1) Applicants submitting to Schuylkill Township a Preliminary Plan application for a proposed subdivision or land development are also required to submit two (2) copies of the preliminary plan in an electronic format. In addition to the preliminary plan, an aerial view of the property that includes at least existing natural features, riparian buffers, flood hazard areas, and existing features within 400 feet of the property should be part of the electronic (i.e., a .pdf or PowerPoint document) submittal.

The applicant shall also use the electronic version of the plan when making their presentation to the Schuylkill Township Planning Commission and the Schuylkill Township Board of Supervisors at their respective meetings. Electronic plan information may be submitted utilizing a DVD disk or thumb drive. *(October 4, 2013)*

- (2) Aerial photograph **may** be accepted on approval by the Schuylkill Township Board of Supervisors for certain natural features.
